HILDA'S PASSION established control soon after the start, showed the way well rated along the inside until the quarter pole, got called upon entering the stretch, drew away to an authoritative score being kept busy to the end. TAR HEEL MOM stumbled at the start, moved up willingly to apply some pressure on the top one, proved no match during the stretch run, held well enough to salvage second. TAMARIND HALL saved ground and missed the place. BRONX CITY GIRL was taken hold after stumbling at the break, raced off the inside and failed to reach a contending position. DEVIL BY DESIGN raced three wide and was through after going a half. SASSY IMAGE leapt at the break, then bore out badly, raced rankly in the early going, appearing to climb for a couple of strides before settling down, continued to lag behind the pack, extremely wide throughout and was never in contention.
