Gray or Roan Filly, (Apr), by Maria's Mon - Discreetly Awesome by Awesome Again. Trainer Pletcher A. Todd. Bred by Mrs. E. Paul Robsham (KY).

AWESOME MARIA advanced between rivals to assume a forward position, was put to a good hold and patiently stalked the pacesetter, remained glued just to that opponent's outside, bid when ready midpoint on the turn, had no soon taken over when confronted by a revved up LIFE AT TEN, was asked for run turning for home and shook free of the aforementioned rival, emerged from the furlong grounds with a sizeable advantage and held sway, being kept busy to the end. PAYTON D'ORO well out in the strip down the backstretch, was guided into the two path early on the turn, stayed there for a short distance, was strung out three wide by three-eighths pole, as SUPER ESPRESSO made her way off the inside in the vicinity of that station, drafted behind LIFE AT TEN into the stretch, tipped outward an additional path for optimal racing clearance, came home with good energy to procure the place. SUPER ESPRESSO rode the rail, picked up the pace approaching the end of the backstretch, found room to ease into the two path at the three-eighths pole, entered the stretch under a full drive and got out finished. LIFE AT TEN was placed under a snug hold leaving the starting gate, remained under it until the half mile pole, advanced three wide to challenge the top one late on the turn, kept up the pressure for a little while longer before flattening out. ABSINTHE MINDED set the early splits from the inside, with the winner in close attendance, was put to the test midway on the turn, succumbed readily despite being heavily urged and faded.
