WISE DAN stumbled at the start but recovered, quickly pulled his way along outside a rival and steadied nearing the wire the first time, chased outside a foe, went three wide on the second turn and four wide into the stretch, rallied under urging to gain the lead three deep in late stretch and was inching away at the wire. ZA APPROVAL angled in and chased outside a rival, went three deep on the second turn and into the stretch, took a short lead outside the pacesetter in upper stretch, inched away in midstretch, fought back between foes in deep stretch and continued willingly to hold the place. SILENTIO stalked the pace inside, waited some leaving the second turn then swung three wide into the stretch, split horses in midstretch, angled to the inside and bid toward the rail and also went on willingly to the wire. SILVER MAX had speed between horses then inside a rival, stalked a bit off the rail on the backstretch, bid alongside the leader midway on the second turn, dropped back between horses leaving that turn and weakened in the stretch. OBVIOUSLY (IRE) sped to the front outside a rival then inched away and angled in on the first turn, set the pace inside, fought off the bid of SILVER MAX on the second turn to inch away again, battled inside the runner-up in upper stretch but weakened in the final furlong. NO JET LAG pulled his way between horses then stalked inside, moved up along the rail then fell back a bit into the second turn, continued inside on that turn, came just off the rail in the stretch and lacked the needed rally between foes late as the rider lost the whip at the wire. CRISTOFORO COLOMBO broke a bit slowly, angled in and settled outside a rival then inside on the backstretch and second turn, advanced along the rail in the stretch then split horses late. HE BE FIRE N ICE angled in and settled inside then off the rail, went four wide on the second turn and five wide into the stretch and could not summon the necessary response. OLYMPIC GLORY (IRE) chased a bit off the rail then inside, went between horses on the second turn and four wide into the stretch and did not rally. BRIGHT THOUGHT pulled his way along outside rivals then stalked alongside a foe, continued between horses on the second turn, dropped back between foes leaving that turn and had little left for the stretch.
