1 1/4 MILES. (Turf) (1.443) STAKES. Purse \$300,000 DEL MAR OAKS (GRADE I) FOR FILLIES, THREE-YEAR-OLDS. By subscription of \$300 each, which shall accompany the nomination, with \$1,000 to pass the entry box and \$3,500 additional to start, with \$300,000 guaranteed, of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weight 122 lbs. First preference will be given to graded or group stakes winners. Second preference will be given to fillies which have finished second or third in graded or group stakes. Total non-claiming purse earnings will determine the order of preference for fillies of equal status. Entry fees will be refunded to all fillies which fail to draw into this race. Nominations Closed Thursday, August 8, 2013, with 23. A trophy will be presented to the owner of the winner. (Rail at 7 feet). (Clear 77)

Gray or Roan Filly, (Apr), by Discreet Cat - To Marquet by Marquetry. Trainer Clement Christophe. Bred by Patricia Generazio(NY).

DISCREET MARQ pulled her way along to stalk the pace inside, came out leaving the second turn, bid three deep into the stretch, gained the lead in upper stretch, inched away and held on gamely under left handed urging. WISHING GATE saved ground chasing the pace, moved up inside on the second turn, came out into the stretch, split horses in midstretch, angled in and finished well. EMOTIONAL KITTEN pulled between horses then chased inside, came out leaving the second turn and into the stretch, was four wide in midstretch and continued willingly to the wire. KITTEN'S DUMPLINGS settled a bit off the rail, went up four wide on the backstretch, angled in on the second turn, came out in upper stretch and also finished with interest. UNUSUAL WAY stalked off the rail, bid alongside the pacesetter leaving the backstretch and on the second turn, was between horses into the stretch and again in midstretch and weakened. NEED YOU NOW (IRE) sped to the early lead and angled in, set the pace along the inside, fought back leaving the backstretch and on the second turn and into the stretch and weakened in the final furlong. CHARLIE EM (GB) pulled between horses early, chased outside a rival then between foes on the backstretch, came out leaving the second turn and three deep into the stretch and lacked a rally. PEARLSIDE (FR) chased outside a rival, went up four wide into the second turn, came three deep into the stretch and could not offer the necessary response. DOINGHARDTIMEAGAIN stalked outside a rival then between horses into the second turn, came out leaving that turn then angled in entering the stretch and weakened. IGHRAA (IRE) unhurried and angled to the inside in the chute, saved ground off the pace, continued inside in the stretch and was not a threat.
