CREATOR completely devoid of speed, began to move into the far turn, strong gain through traffic into the lane, brushed, bit of some tight quarters past the furlong marker, powered clear. SUDDENBREAKINGNEWS also outrun for five furlongs, six wide into the lane, shifted out further to be widest for the drive, closed well to be clear for the place. WHITMORE in tight, bobbed start, was another who raced in the back, four wide into the far turn, fanned six wide into the lane, brushed with the winner inside that one past the furlong marker, no match for that one the final furlong, caught late for the place. DAZZLING GEM settled off the pace while in the three path, began to advance when called on for some run into the far turn, roused with a strong right handed stick midway on that bend, four wide into the lane, challenged midstretch, not enough for the top three late. GETTYSBURG broke sharp, soon got clear, set a glib pace toward the inside, continued to show the way into the lane, weakened. DISCREETNESS ducked in start, raced well back, advanced five wide into the lane, in some traffic and was bothered slightly midstretch, finished up evenly when clear. CUTACORNER behind the pace in the two path, continued toward the inside, waited briefly behind a tiring foe late in the final turn, moved to the rail, finished up evenly. GRAY SKY in a bit tight at the start, stalked the pace three wide, moved a bit closer turning for home, set down, faltered. AMERICAN PIONEER forwardly placed while racing in the two path, had nothing for the drive and gave way. CUPID in tight at the start, was asked to press the issue off the inside, closer second turn, fell apart in the drive. UNBRIDLED OUTLAW within striking distance between horses, gave way in the drive. LUNA DE LOCO in tight at the start, stopped, distanced in the stretch after losing contact with the drive.
