(Foals of 2013) Early Bird Nomination Fee of \$400 due by Monday, December 21, 2015, which includes nomination fee for Lecomte Stakes (GIII) and Risen Star Stakes (GI) (Early Bird). Final nomination for Louisiana Derby closes Saturday, March 12, 2016 by subscription of \$1,000. \$5,000 to enter, \$5,000 additional to start. Supplemental nominations of \$25,000 will be accepted at time of entry which shall include all fees. \$1,000,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight: Colts and Geldings - 122 lbs; Fillies - 117 lbs. Starters to be named through the entry box by the usual time of closing. The Louisiana Derby will be limited to fourteen (14) starters. Preference will be given in the following manner: First preference to graded or group winners in order (I,II,III), then to horses that have accumulated the highest lifetime earnings. Any horse excluded from running because of the aforementioned preference will be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Nominations Closed Saturday, March 12, 2016 with 101. (Cloudy 71)

Chestnut Colt, (Mar), by Candy Ride (ARG) - Quiet Giant by Giant's Causeway. Trainer Steven M. Asmussen. Bred by Besilu Stables, LLC (KY).

GUN RUNNER was well placed on the inside, came off the rail early on the far turn, advanced to make a bid at the five-sixteenths, edged clear under a left-handed whip in upper stretch, switched to a right-handed whip while racing a bit greenly outside the sixteenth-pole and drew away under steady urging. TOM'S READY bumped with UNCLE WALTER at the start, was eager under restraint while four wide through the first turn, settled off the pace, raced between horses leaving the backstretch, was urged along in the two path on the far turn, moved out some under a drive in upper stretch, chased the winner into the final furlong and proved no match while able to get the place. DAZZLING GEM raced in the two path while under a strong hold on the first turn, tracked the pace on the outside, was asked while two then three wide on the far turn, bumped with FOREVERAMO inside the quarter-pole and weakened while just able to get the show. MO TOM went two to three wide on the first turn, settled at the rear, moved closer while two to three wide on the far turn, was coming into the race strongly approaching the quarter-pole, gained directly behind the tiring pacesetter, chose to go inside that rival just as an opening became available to the outside, checked sharply from the three-sixteenths to the eighth-pole, regained some momentum outside the sixteenth-pole and finished willingly to just miss the show but lost any chance. FOREVAMO went four wide on the first turn, settled on the outside, raced three wide early on the far turn, angled five wide near the three-eighths, continued five wide into the stretch, bumped with DAZZLING GEM inside the quarter-pole and lacked the needed response. CANDY MY BOY set the pace on the inside, was asked when confronted by the winner on the far turn, lost the lead to that rival late on that bend, dropped back under a drive in upper stretch and gave way. GREENPOINTCRUSADER settled inside on the first turn, moved out near the five-eighths pole then came under urging on the outside, was hard ridden while four wide on the far turn, floated five wide into the stretch and failed to threaten. CONQUEST WINDYCITY went three wide on the first turn, was reserved near the back, came under urging while three wide on the far turn and was no factor. UNCLE WALTER bumped with TOM'S READY at the start, went three wide on the first turn, settled in fourth position, was urged along while three then four wide on the far turn and came up empty. BATTERY climbed behind the kickback early, raced in the two path on the first turn, settled off the pace under some urging, was urged along while towards the inside on the far turn and failed to respond.
