MEETYOUATHEBRIG came out at the start bumping MONGOOSE, settled in behind horses, reached contention as the field bunched approaching the final quarter, worked his way out six wide nearing the final furlong and was hard ridden to wear down HERO'S TRIBUTE. The latter, never far back and saving ground until nearing the stretch, angled five wide for the drive, reached the front just before the eighth pole, then couldn't contain the winner in a game try. KEATS edged inside early to force the pace, moved after front-running TRU BULL entering the stretch, reached the front briefly between calls approaching the eighth pole, then failed to sustain the needed momentum. MONGOOSE, bumped at the start and forced to check in tight quarters, moved inside, saved ground, raced within easy striking distance into the final furlong and weakened. MATTA, never far back while racing in behind horses, swung out eight wide at the quarter-mile ground but was empty when straightened for the drive. MR. MIESQUE, outrun until the stretch, improved position while not a threat and five wide. OUTOF THEBOX, seven or eight wide most of the way, failed to rally. KAZOO, hustled along the inside early to gain a forward position, held on well into the final furlong and faltered. UNBRIDLED TIME edged inward while forcing the pace, raced forwardly until the stretch and tired. SUDDEN GLORY saved ground but failed to seriously menace. TRU BULL gained the lead early, worked his way inside, opened a clear advantage on the turn but gave way in the drive. HONOURS LIST (IRE) wasn't a factor. DYNAMEAUX was finished early.
