Dark Bay or Brown Horse, (Mar), by Indian Ridge (IRE) - Napoli (GB) by Baillamont. Trainer Bary F. Pascal. Bred by The Niarchos Family (IRE).

DOMEDRIVER (IRE) checked in tight between horses on the first turn, was unhurried while saving ground for five furlongs, launched a rally along the inside on the turn, split horses while gaining rapidly in upper stretch, accelerated to the front inside the furlong marker then edged clear in the final seventy yards. ROCK OF GIBALTAR (IRE) outrun early after breaking a bit slowly, raced well back while four wide along the backstretch, closed the gap on the turn, checked inside LANDSEER at the top of the stretch then unleashed a strong late run in the middle of the track but could not get up. GOOD JOURNEY forced the pace from outside for a half, surged to the front on the turn, opened a clear advantage in upper stretch, continued on the lead into deep stretch then yielded grudgingly. FORBIDDEN APPLE raced in close contention along inside to the turn, dropped back slightly at the quarter pole then finished willingly along the inside. GREEN FEE was pinched back at the start, was outrun while saving ground for six furlongs then rallied belatedly. BEAT HOLLOW (GB) settled in good position between horses along the backstretch, raced within striking distance to the top of the stretch then lacked a strong closing bid. DEL MAR SHOW stalked the pace while four wide for six furlongs, made a run to threaten in upper stretch then flattened out. DRESS TO THRILL (IRE) failed to threaten while racing wide. MEDECIS (GB) was pinched back at the start then failed to threaten while saving ground. TOUCH OF THE BLUES (FR) raced in the middle of the pack between horses to the turn then steadied sharply when LANDSEER broke down at the top of the stretch. ALDEBARAN checked between horses on the first turn, was outrun for six furlongs then steadied sharply at the top of the stretch. NUCLEAR DEBATE raced six wide while in the middle of the pack for five furlongs, steadied sharply on the turn then faltered. BOSTON COMMON set the pace under pressure along the inside for five furlongs and faltered. LANDSEER (GB) raced in the middle of the pack for a half, closed the gap to threaten on the turn then broke down at the top of the stretch.
