ZAGORA (FR) between rivals early, stalked inside, came out some for room into the stretch, bid three deep in midstretch, gained the lead past the sixteenth marker and gamely prevailed under urging. MARKETING MIX tugged her way up to prompt the pace between horses then stalked a bit off the rail, re-bid alongside STAR BILLING into and on the second turn, gained a slim advantage between foes in midstretch and continued willingly to the wire. THE FUGUE (GB) bumped after the start, also pulled and stalked inside, waited leaving the second turn, came out for room into the stretch but was blocked off heels, continued boxed in between and behind horses until past the eighth pole, then split rivals with a bid in deep stretch and finished well. RIDASIYNA (FR) pulled some then settled outside a rival, fell back just off the rail on the second turn, came out for room in midstretch and found her best stride late. LADY OF SHAMROCK bumped and squeezed some after the start, settled inside, waited momentarily in midstretch then came out for room and rallied between horses in the late stages. I'M A DREAMER (IRE) angled in and chased inside, came out a bit for room between horses leaving the second turn, angled in again and lacked room when blocked off heels in midstretch, split rivals in deep stretch and could not quite summon the needed late kick. UP (IRE) bumped early, chased outside a rival then between foes into and on the second turn, came three deep into the stretch and could not offer the necessary response in the drive. STAR BILLING sped to the early lead, dueled inside then inched away early on the backstretch, fought back on the second turn and into the stretch, then steadied when in tight while weakening in deep stretch. IN LINGERIE angled in and pressed the pace three deep then stalked outside the runner-up, continued outside on the second turn and three wide into the stretch and weakened. NAHRRAIN (GB) bumped early, chased three wide, continued three deep on the second turn and into the stretch and also weakened. STORMY LUCY stalked outside a rival then three deep on the backstretch and second turn, came four wide into the stretch and also weakened.
