VIOLENCE stalked between horses then a bit off the rail, moved up inside into and on the second turn, came out nearing the stretch, bid alongside the runner-up in midstretch, gained the advantage under urging past the eight pole and inched away late. FURY KAPCORI had speed off the rail then angled in and dueled inside, edged away on the second turn, fought back in the stretch, could not match the winner late but was clearly second best. DEN'S LEGACY chased inside, split horses into the second turn, continued three deep then four wide into the stretch and bested the others. OXBOW five wide into the first turn, went up to press the pace four wide, stalked outside on the second turn, came three wide into the stretch and weakened. HE'S HAD ENOUGH off slowly, saved ground off the pace, split rivals into the stretch, came out and bumped a foe in upper stretch, split horses again then drifted inward in the lane. CARVING chased a bit off the rail then came out into the backstretch, went four wide into and out of the second turn, was bumped in upper stretch and lacked the needed rally. DIRTY SWAGG squeezed back at the start, chased a bit off the rail then inside into and on the second turn and in the stretch and did not rally. LITTLE JERRY a bit slow to begin, angled in outside a rival and settled off the pace, went three deep into the second turn, angled in again and was not a threat. REALLY MR GREELY had speed three deep then dueled between horses, stalked off the rail on the second turn, was in a bit tight while weakening in midstretch and dropped back. SIMON EYES chased three deep then off the rail, was in tight three wide between foes into the stretch and had little left for the drive. TITLE CONTENDER had speed four wide then dueled three deep between horses, dropped back into the second turn and gave way.
