HUNGRY ISLAND settled in the clear, advanced between rivals mid way on the final turn, angled out four wide into the lane, rallied to collar **TAPITSFLY** leaving the eighth pole, drifted in slightly to be in close proximity with that rival, switched to her left lead and drove clear. **TAPITSFLY** tracked three wide in hand, moved under rating to take command in upper stretch, briefly went clear under pressure in mid stretch, met the challenge of the winner soon after, dueled then gave way grudgingly. **LA REINE LIONNE** hopped after being unprepared at the break, angled in some and was unhurried early, came under pressure leaving the far turn, angled five wide for the drive and closed willingly. **MARKETING MIX** attended the early pace inside **DAISY DEVINE**, was rated back and angled out near the three quarter pole, stalked the pace into the far turn, gained ground inside **TAPITSFLY** approaching the stretch, steadied briefly when lacking room behind rivals in upper stretch, shifted in towards the hedge but came up empty in the final furlong. **DAISY DEVINE** dueled early three wide then went clear moving towards the six furlong marker, dropped in and set a moderate pace, came under pressure into the lane, held well to mid stretch then faded. **HEAVENLY LANDING**, rank when fighting restraint nearing the first turn, saved ground under rating into the far turn, angled out in upper stretch but lacked a rally. **CITY TO CITY** edged closer to be in good position after three furlongs, made progress along the rail entering the stretch, steadied off the heels of **MARKETING MIX** leaving the three sixteenths marker, failed to recover and faded.
