7 FURLONGS. (1.202) STAKES. Purse \$100,000 EIGHT BELLES S. (GRADE III) FOR FILLIES, THREE YEARS OLD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% fifth. Weight: 123 lbs. Non-winners of a Grade I or II stakes in 2012 allowed 3 lbs.; a Grade III or \$45,000 twice since December 25, 5 lbs. The maximum number of starters for the Eight Belles will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners (in order I-II-III), then highest career earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, April 11, 2012 with 20 nominations. (Cloudy 75)

CONTESTED hopped a bit at the start, lost her footing several strides later, quickly gained a forward position on her own courage, challenged the leader from the four path when ready leaving the turn and drew off under steady urging. GOOD DEED sprinted clear, set a fast pace while kept out in the three path, responded willingly when challenged leaving the turn, could not cope with the winner in the final furlong but held on gamely to be second best. ALWAYS HERE TOO outrun early, commenced her rally along the inside after a half, steadied briefly approaching the stretch then improved her position while no threat. LIVI MAKENZIE forwardly placed from the start, moved four wide midway through the turn and tired in the drive. XUNLEI reserved three wide, moved out a path entering the stretch and was no real threat. MY DUE PROCESS within striking distance four wide, raced five wide after a half and gave way. SMALL KITCHEN close up along the inside, faded. VOLCAT stumbled at the start, raced within reach of the lead while off the inside, stopped suddenly after a half and was eased up late.
