SEANEEN GIRL settled in hand four wide, took closer order through the second turn, shifted to the outside of GAL ABOUT TOWN entering the stretch, came to level terms inside the furlong marker and proved best following a prolonged drive. GAL ABOUT TOWN attended the pace four wide, took over entering the stretch, dug in to meet the challenge with a furlong to run, but grudgingly gave in. LIBERATED broke slow, tucked in to save ground, responded when roused near the three-eighths pole, angled out seven wide entering the stretch and kept on well to earn the show. CLOUDY VOW stalked the pace, launched her bid between horses, but weakened during the drive and faded. BROKEN SPELL settled saving ground, moved out and ranged up between rivals on the second turn, loomed a danger entering the stretch but flattened. DANALAKE was shuffled back a bit early and unhurried into stride, closed the gap four wide through the second turn, but faltered entering the stretch and finished evenly. STREET OF GOLD was allowed to settle, came seven wide and finished with a belated gain. POW WOW WOW opened clear to set the pace, was headed entering the stretch and gave way readily. SILVER STRIKE was forwardly placed along the inside, was hemmed in entering the stretch and came up empty in the drive.
