BAY TO BAY pressed the pace out the inside and while unable to gain on the winner, held on gamely for the place. TAPITSFLY within striking distance off the inside, moved out a path on the second turn and lodged a mild late bid. HEAVENLY LANDING close up along the inside while in hand, failed to respond in the stretch. ZAGORA (FR) unhurried off the inside, angled out, raced four wide on the second turn and made a late gain. ARUNA in hand early three wide, stayed in that path on the second turn and showed some late interest.
