MOONWALK tracked three wide, fought on between horses through a prolonged drive and was fully extended to narrowly prevail. KITTEN'S POINT settled between horses, angled out leaving the second turn, kicked on well and was getting to the winner with every stride. SUMMER OF FUN stalked the pace, drew even four wide, poked her head in front with a furlong to run, continued on willingly but grudgingly gave in. OSCAR PARTY contended between horses, angled in on the second turn, shifted to the outside entering the stretch, stayed on through a long drive but reluctantly gave way. SUNSET TIME opened clear to set the pace, was collared entering the stretch and weakened slightly in the drive. HEDONEMEWRONGSONG was allowed to settle four wide, wheeled out eight wide entering the stretch and was making up ground. PURE FUN settled saving ground, shifted out entering the stretch, rallied between horses, was blocked inside the sixteenth pole and was bottled up through the drive. PAPPASCAT was jostled between horses at the start, was forwardly placed along the inside, got through but lacked the needed late response. GO KITTEN GO was unhurried into stride, came five wide and finished with a belated gain. ALWAYS KITTEN was hustled along four wide, but came up empty after six furlongs and dropped out. FREE SONG showed little.
