GROUPIE DOLL was unrushed early three wide, rallied five wide at the quarter pole and drew off late under a steady drive. KITTY IN A TIZZY angled out seven wide at the top of the stretch, rallied and settled for second best. SALLY SALLY stalked the pace four wide, then lacked a late bid. IT'S ME MOM was clear early off of the rail, then couldn't hold off the closers. SWEET CASSIOPEIA raced four wide, bid at the quarter pole, then lacked a late bid. ATLANTIC HURRICANE stalked the pace inside, bid on the turn, then faltered in the drive. ARIANA D was off awkwardly, then improved position late eight wide. INTERROGATE stalked the pace between foes, bid at the quarter pole, then gave way in the drive. SALTY STRIKE was not a factor. BOUQUET BOOTH faded on the turn. HOLIDAY FOR KITTEN stalked the pace three wide, bid at the quarter pole, then gave way in the stretch.
