1 1/2 MILES. (Turf) (1.454) STAKES. Purse \$400,000 *QUEEN ELIZABETH II CHALLENGE CUP S. (GRADE I) FOR FILLIES, THREE YEARS OLD.* By invitation with no nomination or starting fee, with \$400,000 guaranteed of which \$240,000 to the owner of the winner, \$80,000 to second, \$40,000 to third, \$20,000 to fourth, \$12,000 to fifth and \$8,000 to be divided equally among sixth through last. Weight: 121 lbs. The Keeneland Association will invite a representative field of twelve fillies to compete. The field will be drawn by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey. In the event that this race is taken off the turf it will be contested at One Mile and One-Eighth on the main track. (Cloudy 67)

DAYATTHESPA opened clear and tucked in to dictate terms off of the inside, inched away after a half, responded when set down for the drive and held gamely. CENTRE COURT was reserved off of the pace four wide, loomed a danger entering the stretch, kicked on well but was unable to bridge the gap. BETTER LUCKY tracked the pace three wide, went evenly through the drive and was all out to hold the show. SAMITAR (GB) settled in hand between horses, shifted out and split rivals nearing the furlong marker but was unable to improve position. SOMALI LEMONADE was bumped early and unhurried into stride, angled out five wide but lacked the needed punch. STEPHANIE'S KITTEN was in tight early and bumped with SOMALI LEMONADE, settled saving ground while never far back, got through entering the stretch but lacked a response when put to pressure. TREASURED UP saved ground to no avail. TANNERY (IRE) was unhurried into stride along the inside, angled out entering the stretch but failed to threaten.
