Non-winners of \$100,000 at a mile or over allowed 2 lbs.; a sweepstakes at a mile or over allowed 4 lbs.; non-winners of two races other than claiming or starter at a mile or over allowed 6 lbs.; such a race allowed 8 lbs. BOBINA settled inside, came out leaving the second turn and four wide into the stretch and rallied under urging to gain a slim lead in deep stretch, bumped with the runner-up late and broke down and fell on the wire. MY GI GI stalked three deep on the first turn then outside a rival, bid three wide into the stretch, gained the lead, drifted out some past midstretch, bumped with the winner in deep stretch and continued willingly to just miss. BYRAMA (GB) chased outside a rival, went three deep into the second turn, angled in some leaving that turn, steadied briefly off heels in midstretch then split horses and gained the show while being steadied again just before the wire. GRASER (IRE) pulled her way between horses to chase the pace, continued between foes on the second turn, came out four wide into the stretch and bested the others. VIA VILLAGGIO pulled her way along and angled in, stalked inside, bid along the rail a half mile out, tracked the leaders while saving ground on the second turn, steadied in tight into the stretch, went around a rival in deep stretch and could not summon the needed late kick. BELLE PASSE had speed outside then inched away on the first turn, set the pace off the rail, dueled three deep passing the half mile pole then outside a rival on the second turn, put a head back in front into the stretch, battled inside the runner-up in the drive and weakened late. LIGHT OF LIFE stalked inside then bid between horses a half mile out, dueled along the rail on the second turn and into the stretch and weakened in the final furlong. Following a claim of foul by the rider of the runner-up against the winner and a stewards' inquiry, no change was made when the stewards ruled the contact between the top pair was mutual.
