5<sup>1</sup>/<sub>2</sub> FURLONGS. (Turf) (1.021) STAKES. Purse \$100,000 *SHAKERTOWN S. (GRADE III) FOR FOUR YEAR OLDS AND UPWARD*. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 guaranteed, of which \$60,000 to the owner of the winner, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I or II stakes since No vember 3, allowed 3 lbs.; \$45,000 since October 7, 5 lbs. The maximum number of starters for the Shakertown will be limited to twelve with two also eligibles. In the event that more than twelve pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest turf earnings in 2011-2012. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the owner of the winner. Closed Wednesday, April 4, 2012 with 23 nominations. In the event that this race is taken off the turf it will be contested at the Five and One Half Furlongs on the main track. (Cloudy 66)

**PERFECT OFFICER** within striking distance off the inside, responded willingly in the stretch and closed fast to be up in the final stride.

**GREAT MILLS** sprinted clear into the turn, set a fast pace but was outfinished. **ZEB** out sprinted early, came five wide into the stretch and made a good late gain. **HAVELOCK** outrun early, swung out six wide leaving the turn and was too late in the middle of the course.

**SURFRIDER (IRE)** broke slowly, was outrun early, raced off the rail on the turn and lodged a mild late bid. **GREAT ATTACK** close up while off the inside, held on ell to the stretch and weakened. **CHAMBERLAIN BRIDGE** prominent three wide, stayed on well to the stretch and tired.

**UNSADDLED GLORY** within striking distance four wide, also tired. **BYESVILLE** was outrun. **CONCORDE'S FLIGHT** forwardly placed along the inside, stopped.
