Chestnut Filly, (Mar), by Speightstown - Dance to Dawn by Louis Quatorze. Trainer Figgins, III L. Ollie. Bred by Mr. & Mrs. David Garner (KY).

DANCE TO BRISTOL away with no apparent mishap, sat patiently perched out in the four path, within range of the front runners, was let out a notch and moved up past GLORIOUS VIEW leaving the five-sixteenths pole, taking over that rival's path and poised to strike as the field headed into the stretch, continued to whittle away at the lead for about another sixteenth before given her cue, responded positively to take over by a slim margin at the eighth pole, dug in resolutely never leading by more a half length at any time, kept to the task at hand. BOOK REVIEW unhurried from off the inside, worked out a tuck into the two path in the vicinity of the seven-sixteenths pole, took it for a furlong before proceeding to get angled outward sharply, commenced the drive home from near the five path, gained ground readily travelling through the furlong grounds, forged on ahead with no loss of momentum, hooked up in a belated duel with the winner, battled gamely but got denied by an equally-game opponent. VILLANESCA was coaxed along while taking the inside route for nearly a half, got asked for run and swung four wide into the stretch, advanced into a contending position with an eighth to go, failed to pick up any additional real estate, while still finishing willingly for the show award. STREET GIRL sat reserved while riding the rail until the five-sixteenths pole, got taken outward at that station and eventually fanned six wide into the stretch, with only rival coming into it wider, got straightened away and had a good finish down the outside of the strip to earn the last major check. CLASSIC POINT gained a short advantage after the start and was guided over to the inside, was rated cutting the pace, with another pair parked out in paths two and three wide making their presence felt, came to end of the bend and got called upon, got reeled in by the winner by midstretch, weakened steadily thereafter. STARSHIP TRUFFLES broke to the outside, bumping with MOMENT IN DIXIE and then engaging in an abbreviated jousting match right afterwards, was sent over to the inside a short distance past the half mile pole, went on a little further before getting put to a drive, improved position cutting the corner into the lane past many in the field having chosen to take much wider routes into the stretch, flattened out. FANTASY OF FLIGHT prompted CLASSIC POINT from the two path until the quarter pole, was asked for some run and challenged in earnest at that juncture, kept up the pursuit for another furlong before backing away. SURE ROUTE (GB) four wide at the top of the turn, was in the five path exiting it, failed to reach contention. MOMENT IN DIXIE bumped several times with STARSHIP TRUFFLES during the very initial stages, chased three wide on the turn, drifted into the seven path coming to the three-sixteenths pole with little left to offer. GLORIOUS VIEW underwent a few light bumps at the start, pressed the issue three wide until the five-sixteenths marker, folded.
