HESSONITE just off the pace inside saving ground within close range of the front and behind cover, came under light coaxing nearing the quarter pole, lacked clearance inside and remained patient until roused and angled sharply a furlong out to the five path, saw daylight under a brisk brief hand drive and surged by in the last jumps confidently handled to prevail. PEACE PRESERVER two to three wide towards the rear of a compact group, came under urging at the five-sixteenths, swung three wide in upper stretch, rallied with good energy to collar DREAM PEACE just inside the sixteenth marker, led briefly before overhauled in the final strides by the aforementioned rival in a good effort. DREAM PEACE (IRE) three deep within aim of the front well rated, got set down continuing three wide at the quarter pole, rallied to take command a furlong out inching away briefly, got displaced inside the sixteenth marker and was outfinished in the late stages by the top pair. SUROOF on the pace inside in hand through sensible fractions, remained patiently handled until roused cutting the corner into the stretch, dug in fighting on for the lead until displaced nearing the final furlong, kept on mildly thereafter for the last major share. NAPLES BAY rated just off the leader from just off the inside, came under encouragement at the five-sixteenths, offered up a mild rally battling head to head through the lane with SUROOF while being out kicked to the wire. RUTHENIA just off the inside towards the rear of a compact field, got set down angling four wide in upper stretch and offered no serious response.
