Gray or Roan Filly, (Apr), by Macho Uno - Naturally Wild by Wild Again. Trainer Pletcher A. Todd. Bred by Tanourin Stable(FL). SILSITA stalked the pace four wide, drew even with three furlongs to run, battled fiercely thereafter and was fully extended to prevail by the narrowest margin. MARATHON LADY attended the pace along the inside, slipped through and forged command near the seven-sixteenths pole, fought on gamely but was denied following a prolonged drive. PURE FUN settled in hand, advanced between horses into striking position, tipped out five wide entering the stretch, loomed large but toiled through the final furlong and failed to improve further. BROKEN SPELL was allowed to settle, came five wide to make a mild bid but lacked the needed late response. MISS SQUEAL settled off of the inside, got through to close the gap, came four wide and improved position. STREET OF GOLD saved ground to little avail. ANAHAUC was unhurried into stride, swung seven wide and finished with a belated gain. AWESOME MAMA was close up five wide through the second turn and tired. ALWAYS KITTEN stumbled at the start and never recovered. LE FASCINATOR failed to respond. CORPORATE CULTURE was through after a half. MARTHA'S MOON opened clear to set the pace off of the inside, was collared between horses near the seven-sixteenths pole, stopped once headed, was eased to the wire but walked off.
