BOND HOLDER angled in and chased inside, came out leaving the second turn and into the stretch, rallied under urging to gain the lead in deep stretch and won clear. DANCE WITH FATE forced out a bit into the first turn, stalked outside a rival, bid alongside the leader into the stretch, took a short lead, could not match the winner late but was clearly second best. TAMARANDO broke into the side of the gate in a slow start, settled inside then just off the rail, angled in again into the stretch, split rivals in midstretch and picked up the show late. CAN THE MAN pulled his way along inside then bid alongside a rival to duel for the lead, inched away on the second turn, fought back inside into the stretch and weakened some late but lost third nearing the wire. FLAT GONE angled in and settled outside a rival or off the rail, came out into the stretch and put in a late bid at a minor award. TEST RIDE pulled his way along outside then inched clear and angled in, set the pace inside, dueled on the backstretch and into the second turn, stalked on that turn and weakened in the stretch. BETTER BET forced wide into the first turn, stalked outside a rival, came four wide into the stretch and did not rally. ONTOLOGY drifted out into the first turn, stalked just off the rail and weakened in the stretch. EVEN ECHO steadied and was forced out off heels into the first turn, chased just off the rail, fell back on the second turn and had little left for the stretch. ROUNDUPHELUTE allowed to settle outside a rival or off the rail, came three wide into the stretch and weakened.
