7 FURLONGS. (1.20Z) STAKES. Purse \$150,000 GULFSTREAM PARK SPRINT CHAMPIONSHIP S. (GRADE III) FOR FOUR YEAR OLDS AND UPWARD. Free nomination by Saturday, January 26, 2013, \$1,500 to pass the entry box and \$750 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000; \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Weight: 123 lbs. Non-winners of a grade I since August 1, allowed 2 lbs.; a grade II since August 1, 4 lbs., a grade III or \$60,000 since September 1, 6 lbs., Supplemental nominations may be made at time of entry at a fee of \$7,500, which includes entry and starting fees. Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 Starters, with Also Eligibles. If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners, then highest 2011-2013 earnings. Trophy to winning Owner. The latter, stalked the pace along the rail, swung out for the stretch run and was gaining slowly on the winner just up for the place. **BAHAMIAN SQUALL** dueled for the lead outside **FORT LOUDON** to deep stretch and yielded. **CLOSE IT OUT** unhurried early, angled wide in the stretch and closed with a belated rally. **GOOD MORNING DIVA** rated off the pace, raced four wide around the turn and had no response when asked. **TRAVELIN MAN** chased the pace four wide around the turn, then gave way. **FAIR WHIT** was outrun. **BIG GRANDPA** vied for the lead three wide to midway of the turn and faltered.
