1 1/8 MILES. (Turf) (1.442) STAKES. Purse \$300,000 *GULFSTREAM PARK TURF H. (GRADE I) FOR FOUR YEAR OLDS AND UPWARD.* By subscription of \$300 each by Saturday, January 26, 2013, which shall accompany the nomination, \$3,000 to pass the entry box and \$1,500 additional to start, with \$300,000 Guaranteed. All fees shall be paid before the start of the race. Supplementary nomination by Noon Friday February 1, at a fee of \$15,000 which includes entry and starting fee. The owner of the winner to receive \$180,000, \$60,000 to second, \$30,000 to third, \$15,000 to fourth, \$9,000 to fifth and \$6,000 to sixth. Weights: Saturday, February 2, 2013. This race will be limited to 14 Starters, with Also Eligibles. High Weights Preferred with second preference to horses with the highest lifetime earnings. Starters to be named through the entry box by the usual time of closing. In the event this stakes is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee. Trophy to the winning owner. Nominations Close Saturday, January 26, 2012 with 21 Nominations (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 108 feet). (Clear 79)

POINT OF ENTRY stalked the pace three wide, rallied to gain a slim lead at the eighth pole, then edged away late under urging. ANIMAL KINGDOM reserved early, rushed up along the rail to reach even terms for command with SALTO leaving the backstretch, gained the advantage midway of the far turn, made the pace into the stretch, responded when headed at the eighth pole but couldn't stay with the winner late. UNBRIDLED COMMAND tracked the leaders off the rail, advanced to loom a threat in midstretch but couldn't gain late. SALTO (IRE) set the pace off the rail, responded when ANIMAL KINGDOM rushed up inside him on the backstretch, stayed with that rival to nearing the top of the stretch, then tired. WHERE'S THE BABY failed to menace. FILM MAKING tracked the pace along the rail into the far turn and faded.
