CENTRE COURT well placed racing along the inside, angled three wide on the far turn, rallied to take over nearing the eighth pole, then edged away under urging. SAMITAR (GB) allowed to settle, saved ground into the stretch, eased out and rallied to be up for the place. FRONTSIDE quickly moved to the fore while angling over to the rail, made the pace into the stretch, then weakened. CHANNEL LADY rated off the pace, advanced into contention four wide around the far turn but couldn't gain late. PIANIST chased the pace off the rail into the stretch and gave way. CLASS INCLUDED failed to menace. HEAVENLY LANDING was not a factor. STAR TORINA stalked the leaders off the rail into the far turn, then faltered.
