PRINCESS OF SYLMAR was roughed up between horses at the start, settled off of the inside, advanced between horses after the opening half, continued the advance four wide through the second turn and wore down the leaders in the final yards. BEHOLDER was fractious in the post, unseated her jockey and was off her feet briefly, broke outwardly bumping UNLIMITED BUDGET at the start, recovered quickly and tracked the pace three wide, came to level terms with a quarter to run, shook clear and continued on well but was unable to resist the winner. UNLIMITED BUDGET was bumped at the start, pulled to contention four wide, loomed a danger entering the stretch but went evenly through the drive and was all out to hold the show. DREAMING OF JULIA was bumped between horses at the start, tucked in to save ground, was asked for run after a half, advanced reluctantly toward the inside, steadied near the seven-sixteenths pole, leveled back into stride on the second turn, worked her way to the outside with five-sixteenths to run, came six wide but was left with too much to do. MIDNIGHT LUCKY was away in good order, opened clear to dictate terms, was collared nearing the quarter pole, relinquished the lead entering the stretch, then continued to weaken in the drive. PURE FUN was jostled hard at the start, lagged well back, finished with a belated gain between horses but failed to threaten. CLOSE HATCHES was allowed to settle four wide, came five wide and made a mild improvement through the lane. ROSE TO GOLD broke inwardly and bumped DREAMING OF JULIA at the start, was straightened away and attended the pace four wide, came up empty before going six furlongs, steadied between horses as she was retreating near the three-eighths pole and showed little thereafter. SEANEEN GIRL settled off of the inside, moved up between horses on the second turn to make a mild bid but failed to sustain the drive. SILSITA was forwardly placed along the inside for six furlongs and stopped.
