RUMOR stalked a bit off the rail, split horses leaving the turn, came out some in the stretch, bid alongside the runner-up under left handed urging past midstretch, gained the advantage in late stretch and gamely prevailed. TEDDY'S PROMISE broke in and bumped a rival, had speed between foes then dueled outside a rival, inched away leaving the turn, fought back when challenged again in the stretch and continued gamely to the wire but could not quite match the winner late. SHUMOOS had good early speed and dueled inside, fought back on the turn, weakened in the stretch but held third. SUGARINTHEMORNING pressed the pace three deep then stalked outside, continued three wide on the turn and into the stretch and weakened. BELLE OF THE HALL dropped back along the inside, saved ground chasing the pace throughout and did not rally. DISTRACTING was bumped by the runner-up at the start then bobbled in the initial strides, pulled her way up four wide on the backstretch, continued outside on the turn, fell back off the rail into the stretch and weakened.
