1 MILE. (Turf) (1.314) STAKES. Purse \$200,000 (US \$193,820) *NASSAU S. (GRADE II)* FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD. By subscription of \$200 each which shall accompany the nomination and an additional \$2,000 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds, 119 lbs.; Older, 125 lbs. Non-winners of a Grade I race at a mile or over in 2012-2013, allowed 3 lbs.; Of a Grade II race at a mile or over in 2012-2013, 5 lbs.; Of a Grade III race at a mile or over in 2012-2013, 7 lbs.; Of \$60,000 at a mile or over in 2012-2013, 9 lbs. (No Canadian Bred Allowance) (Note: Grades as recognized by the International Cataloguing Standards Committee.) Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$4,000, which includes the entry fee. (Closed with 21 Nominations) *Plus up to \$24,300 OntarioSi red/Ontario Bred Breeder Awards. (Clear 13)

SOLID APPEAL raced in midpack three-wide, chased into the stretch, challenged midstretch and drove clear. IRISH MISSION raced in midpack, saved ground, tendered a rail bid midstretch but was outkicked. NORTHERN PASSION settled off the pace, angled off the rail late turn, was involved in some bumping with PART THE SEAS through the stretch but finished determinedly. DANCING TO TOWN set a pressured pace on the backstretch, moved clear into the turn, was in reserved to the stretch but was joined midstretch and gave way. ENGLISH CLASS stalked the pace in hand, chased into the stretch, failed with a bid midstretch and evened out. PART THE SEAS raced in midpack along the rail, was hustled into the stretch, bumped with NORTHERN PASSION several times then evened out in the late stages. TRANSGRESSION pressed the pace, stalked on the turn, pulled up in distress midturn and was vanned off.
