WITHGREATPLEASURE settled tracking the pace along the inside within aim, took closer order on the leader three furlongs out, came under encouragement at the five-sixteenths, cut the corner into the stretch to the front, edged away to the eighth pole, had her main challenge latch on a sixteenth from home, dug in to repulse the bid and prevail. MY WANDY'S GIRL four wide in mid pack, came under urging at the five-sixteenths, advanced on the front, swung four wide into the stretch, rallied steadily gaining through the final sixteenth but was repulsed to the wire while safe for the place. TWICE THE LADY three wide towards the rear, came under a ride at the five-sixteenths, angled four wide in upper stretch, continued out a path straightened for home, offered up a belated kick to just get up for the show while never threatening the top pair. CENTRIQUE stumbled slightly at the start, raced three wide in close range in pursuit while in hand, got set down nearing the quarter pole continuing three wide at that station, offered up a mild kick to remain prominent through the stretch before weakening in the very late stages. FUNNYS APPROVAL a bit fractious in the gate prior to the start, shook away to assume the front under light coaxing from just off the inside, had the field take closer order three furlongs out, got set down in earnest at the head of the stretch and was displaced on the front then weakened steadily thereafter. ONEPOINTTHREEKARATS just off the inside towards the rear, got called upon to pick it up at the five-sixteenths, angled three wide at the quarter pole, shifted out an additional path straightened for home and offered no response.
