UNUSUAL WAY tracked inside, came out and moved up passing the quarter pole and finished well to best the others. COUNTESS CURLIN raced off the pace inside, came three wide into the stretch and rallied mildly late. INFINITELY raced four wide into the clubhouse turn, settled off the pace and gained mildly late for fourth. FRAUDULENTFOOTNOTE raced off the pace inside and failed to threaten. CANTICLE stalked two wide, raced three wide on the far turn and failed to respond. MAJESTIC RIVER set the pace on the inside and tired. SHESATOPATTRACTION raced four wide early, continued three wide and gave way.
