DEPARTING away in good order, four wide when off the pace in the first turn, moved closer backstretch while continuing outside, challenged midway on the final turn, dueled into the stretch, drove steadily clear. RULER OF LOVE bobbled slightly start, took control soon after the start, moved to the inside, set a leisurely set of early fractions, briefly raced on equal terms with the winner when that one came alongside in the second turn, no match in the drive, clearly second best. CAMEO APPEARANCE closest to the leader for almost six furlongs, asked along turning for home, little in the way of a response, comfortably saved the show. TREASURY BILL off the pace, raced between foes through the first turn, in the two path through the second bend, continued evenly to the wire. RUNAWAY STEPHEN bumped at the start, trailed, five wide turning for home, showed little in the way of a late rally. BASHAAR last away, raced back, failed to threaten. HOLIDAY MISCHIEF bumped at the start, raced forwardly and inside, retreated after a half.
