GLORIOUS VIEW cut solid fractions along the inside prompted from the two path, came under light coaxing approaching the quarter pole, shifted out a path straightening for home set down for the drive, kicked on challenged by FANTASY OF FLIGHT rallying on nearly even terms a furlong out, dug in stubborn fighting on gamely to the wire inching away in the final strides to prevail. FANTASY OF FLIGHT three wide in pursuit within aim of the aforementioned rival, came under urging at the five-sixteenths, continued three wide for home, rallied to get on nearly even terms with GLORIOUS VIEW a furlong out, fought on with good energy but was ultimately repulsed to the wire. WITHGREATPLEASURE a bit fractious prior to the start, broke open the gate which in turn inspired SPECTACULAR SKY to break through her stall prior to the start, was backed out and reloaded, chased from the two path towards the rear early on, angled five wide into upper stretch, kicked home belatedly for the show honors. MISS D'ORO saved ground towards the rear, came under encouragement at the five-sixteenths, angled four wide into the stretch inside WITHGREATPLEASURE then offered up a mild kick through the lane. SPECTACULAR SKY broke through the gate prior to the start when getting unsettled by WITHGREATPLEASURE who broke open her gate just prior, prompted the pace from just off the inside coaxed along, swung three wide into the stretch when losing position nearing the quarter pole and hence her lane then weakened in the drive. IRISH EXCHANGE tracked the pace from the two path in close range of the front, came under a ride at the five-sixteenths, seemingly looked to angle out at the quarter pole but had the lane occupied by the eventual winner, shifted to cut the corner into the stretch and weakened in the final eighth.
