1½ MILE. (1:45<sup>2</sup>) STAKES. Purse \$1,000,000 (Includes \$690 Other Sources. Pluses \$690 Other Sources.) Santa Anita Derby FOR THREE-YEAR-OLDS. By subscription of \$500 each to accompany the nomination (EARLY BIRD) on or before Sunday, December, 27, 2015 (closed with 93). Early Bird nominees to the Santa Anita Derby are automatically eligible to, the Sham Stakes (Grade III), the Robert B. Lewis Stakes (Grade III), and the San Felipe Stakes (Grade II) with nomination and starting fees waived to those stakes. Regular nominations close Saturday, March 26, 2016 by payment of \$2,500 each, closed with 4. Supplementary nominations are due at time of entry, by payment of \$20,000. All horses shall pay \$5,000 to enter and \$10,000 to start, with \$1,000,000 guaranteed. The winner to receive \$600,000 PLUS 100 KENTUCKY DERBY POINTS, \$200,000 to second (40 KY DERBY POINTS), \$120,000 to third (20 KY DERBY POINTS), \$50,000 to fourth (10 KY DERBY POINTS), \$20,000 to fifth and \$10,000 to sixth. 124 lbs. A trophy will be presented to the winning owner. (Showery 65)

EXAGGERATOR unhurried along the inside early, came out into the second turn, advanced outside, entered the stretch three wide, swept to the front in upper stretch, drifted to the inside but drew clear under left handed urging and a long hold late. MOR SPIRIT angled in nearing the first turn and chased inside, came out leaving the second turn and into the stretch and went around rivals past midstretch to gain the place. UNCLE LINO angled in and stalked the pace just off the rail, bid outside the pacesetter on the second turn, took the lead into the stretch, was not a match for the top pair in the final furlong but clearly bested the others. DANZING CANDY a bit fractious in the gate, sped to the early lead, set the pace inside, dueled along the rail on the second turn and into the stretch and weakened. DIPLODOCUS broke a bit slowly and was squeezed some, angled in on the first turn, settled off the pace inside, came out a bit nearing the second turn and three wide into the stretch and did not rally. DENMAN'S CALL drifted out into the first turn, angled back in and chased inside, came out some into the stretch and weakened. SMOKEY IMAGE pulled his way along three deep then stalked outside a rival, dropped back and drifted out on the second turn, came four wide into the stretch and gave way. IRON ROB pulled between horses then chased outside a rival, dropped back leaving the backstretch, gave way and was eased in the stretch. DIPLODOCUS wore calks.
